Necessary Documents for **FACTORY LICENSE AMENDMENT**
(Hazardous Factory)

(SLA Timeline 30 days as per RTS)

1.	ADHAR CARD / PASSPORT
2.	FORM 1 DULY SIGNED BY OCCUPIER AND MANAGER
3.	LIGHT BILL/LOAD SANCTION LETTER FOR INCREASE IN CONNECTED LOAD (IN CASE OF HP CHANGES)
4.	PREVIOUS APPROVED FACTORY LICENSE COPY
5.	LATEST PLAN APPROVAL LETTER
6.	REQUEST LETTER STATING THE NATURE OF AMENDMENT & DATE FROM WHICH WORKERS OR HP HAS INCREASED / DECREASED.
7.	FRESH CERTIFICATE INCORPORATION (IN CASE OF FACTORY NAME CHANGE)
